

**Welcome to the Badger State Auto Auction Family- we are glad you are here!**

The following policies apply to all dealers and are intended to provide guidelines regarding policies and procedures at Badger State Auto Auction.

1. All vehicles sold for \$1505 or less are “as is”, and therefore are **not arbitrateable**.
2. When purchasing a vehicle with an “auction guarantee” you will have **one hour** to arbitrate it.
3. If you are not in agreement with the arbitrators decision, you may elect next day arbitration. In this case, we will send the vehicle to an authorized shop to have it checked out. You must notify the arbitrator of this the night of the sale, and you will be responsible for all costs. However, if you were correct and the arbitrator was in error, you will not have to accept the vehicle.
4. Vehicles bought on an “If” must also be arbitrated within **one hour** of purchase. It will take approximately 30 minutes for the If office to inform you of the selling dealers price, however it does not become a two way If until the end of the sale. You can counter offer a price, at which time the staff in the If office will inform you when you will have an answer. All “24 hour If’s” will be answered on Friday.
5. All vehicles must be paid for the night of the sale or a **\$50.00 late fee** will be assessed.
6. **New dealers** are immediately eligible for our “Early Bird” drawing. Cash and prizes are given away each week prior to the auction starting. Just be in the block area prior to 4:45pm, and if your bid number is called, you win! It’s that easy.
7. **New dealers** must adhere to the following policies when purchasing vehicles at the first auction you attend when paying by check:
  - a. Checks will be deposited the night of the sale.
  - b. We will hold titles until the check has cleared.
  - c. Bank letter and references will be checked out.
  - d. Upon receiving bank information and reviewing your business transactions for a period of 30 days, it will be at management’s discretion to release titles and set up a credit line.
8. We offer 350+ 30 days float vehicles each week. As a new dealer, you are eligible to receive transportation assistance or a discount of \$25.00 per vehicle up to a \$5000 purchase price, or a \$50.00 discount per vehicle for purchase price of \$5000 and over. You will continue to receive this discount on float vehicles until you are eligible for the Float Program.
9. There is a grace period of **90 days** for **new** dealers to purchase float vehicles. Upon receiving the Bank Letter and reviewing current business transactions, it will be at management’s discretion to allocate grace period and set up credit line. See our General Manager Tim Netz if you have any questions.
10. We have several options for helping you get your vehicles home, via haulers or delivery. Please inquire at Check-In for assistance. All vehicles must be picked up within 2 weeks or they will be towed at your expense.
